CCGP Annual Meeting Held in National Harbor, MD

The annual meeting of the Commission for Certification in Geriatric Pharmacy was held in conjunction with the annual meeting of the American Society of Consultant Pharmacists at the Gaylord National Hotel in National Harbor, Maryland on November 15, 2012. CCGP Board Chairman Ken Tuell presided at the meeting. Approximately 70 persons attended the breakfast meeting, where an update was provided to attendees on CCGP activities.

CCGP Sponsors Dinner for PGY2 Geriatric Program Directors

The American Society of Health-System Pharmacists is the accrediting body within the pharmacy profession for residency training programs for pharmacists. ASHP accredits 13 geriatric residency programs in the United States. These are all second year programs (PGY2), requiring completion of a post-graduate year one (PGY1) residency prior to enrollment.

During the ASHP Midyear Clinical Meeting in December 2012, CCGP sponsored a dinner for the directors of the geriatric PGY2 residency programs. This was an opportunity for these program directors to network and talk with one another, as well as an opportunity for CCGP to establish a better

Number of CGPs Surpasses 2,000

Over 2,000 pharmacists currently hold the Certified Geriatric Pharmacist credential. This is a landmark in the growth of the CGP credential, representing strong interest in credentialing on the part of pharmacists. As the baby boomers continue to age, and as the job market for pharmacists tightens, more pharmacists are seeking the CGP credential as a way to enhance marketability or job security.

During the October/November 2012 test window, 189 pharmacists took the CGP examination. This was a record number of pharmacists to take the exam in a single test window since CCGP changed the format of the examination to the computer-based exam.
