## PROPOSED AMBULATORY CARE SPECIALTY CERTIFICATION; CALL FOR COMMENTS

CCGP's Board of Commissioners provided written comments to the Board of Pharmaceutical Specialties' (BPS) regarding the petition to recognize ambulatory care as a new specialty practice. BPS was petitioned jointly by the American College of Clinical Pharmacy (ACCP), the American Pharmacists Association (APhA), and the American Society of Health-System Pharmacists (ASHP) in November 2008 to consider this specialty. Upon reviewing the documents provided by BPS, CCGP Chair Jane Huff noted, "While chronic conditions can occur at any age, the large majority of ambulatory patients who fit these descriptions are older adults, for whom the special skills of geriatric management are critical. A pharmacist may be knowledgeable about principles of pharmaceutical care or disease management, but the application of this knowledge to older adults requires a different set of skills and knowledge that goes beyond management of individual diseases."

With this in mind, CCGP and ASCP respectfully requested that BPS consider the following questions before approving the new specialty certification:

On November 19, 2008, nearly 100 Certified Geriatric Pharmacists (CGPs) gathered for the 11th Annual Meeting of the Commission for Certification in Geriatric Pharmacy (CCGP). **Jane Huff**, RPh, CGP, chair of the Board of Commissioners, welcomed everyone, presented awards, announced outgoing and incoming board and committee members, and introduced speakers.

Huff introduced **Mary Ann Zagaria**, PharmD, MS, CGP, who is the 2008 recipient of CCGP's Excellence in Geriatric Pharmacy Practice Award. The award was officially presented earlier in the day at the opening general session of Senior Care Pharmacy '08, ASCP's 39th Annual Meeting and Exhibition.

# DELAYED SCORING FOR RECENT CCGP EXAMINATIONS

For candidates taking the examination for certification in geriatric pharmacy in the months of January and February 2009, you may wonder why you have not yet received your score. When a new form of an examination is released to candidates, it includes new (never tested) items. After a specific number of candidates complete the examination, item statistics are reviewed to ensure the questions are performing as expected by the examination committee and in a psychometrically sound manner. Once the accuracy of the individual questions is verified, your final test score is calculated and the passing score of the new examination form is determined. At that point all January-February candidates will be sent a new score report with a pass or fail designation. Candidates scheduled for March 2009 and future testing windows will receive score reports with pass/fail designations when they complete the examination.

### A YEAR IN REVIEW FOR CCGP IN 2008

The Commission for Certification in Geriatric Pharmacy celebrated continued growth in its 11th year. In 1997, 100 pharmacists sat for the first exam in Philadelphia to demonstrate their competency as Certified Geriatric Pharmacists (CGPs). Since then, more than 1,800 pharmacists have earned this prestigious credential. Over the years CGPs have been increasingly sought after for their expertise in the unique medication-related needs of the elderly.

CGP numbers and influence continue to grow. This year close to 200 pharmacists became board certified and 150 CGPs recertified. CGPs report working in the community, in managed care organizations, in the Veterans Administration health system, in academia, and in the pharmaceutical industry. Roughly 40% work primarily in long-

term care pharmacy and 18% work in hospital pharmacy. International growth continues also Board-certified geriatric pharmacists practice in Australia, Canada, Japan, Singapore, and Sweden. In fact, thirteen pharmacists from Australia successfully passed the exam just this past September.

CCGP continues to promotes the CGP credential as **the only board certification** for a pharmacist that demonstrates competence in geriatrics and geriatric pharmacotherapy, and is working to promote the credential in a variety of practice settings. A work group was formed this year to encourage assisted living communities to hire board-certified geriatric pharmacists. The work group developed a one-page document defining the value of the CGP in assisted living, and published it in the October issue of *The Credential*, CCGP's quarterly newsletter. Next steps include distributing this document to assisted living communities and developing a study to demonstrate the value of the Board-Certified Geriatric Pharmacist providing medication management services in assisted living communities.

On the managed care front, a work group of CGPs submitted a presentation for consideration at the annual meeting of the Academy of Managed Care Pharmacy (AMCP) in April 2009. This presentation would help educate managed care pharmacists and organizations on the special medication needs of the geriatric population, and the specialized knowledge of CGPs to address these issues. Recognizing this already, Humana committed to registering 20 pharmacist employees for the certification exam within the next year.

A third work group is developing outreach initiatives to promote the CGP credential to student pharmacists. This group will be working with schools of pharmacy to develop specialized pathways for students to seek board certification on an accelerated basis.

CCGP continues to make great strides to gain recognition for CGPs in the health care community. Board members discussed the critical success factors and strategies to foster growth and recognition of the credential. The Commission will continue its outreach to pharmacists currently practicing in geriatrics, to student pharmacists interested in pursing careers in geriatrics, and to payers seeking credentialed pharmacists to provide services to seniors.

The statistics and implications of aging, medication-related problems, and the impact of pharmacists' interventions are well known. **CGPs can and do make a difference** in the lives of older adults. Learn more about the importance of board certification as part of your career path. Make a commitment to demonstrate your competence as a senior care pharmacist by seeking board certification in geriatric pharmacy.

### 53 PHARMACISTS ACHIEVE BOARD-CERTIFICATION ON GERIATRIC PHARMACY

B etween October 1 and December 31, 2008, 53 pharmacists successfully completed the Certification Examination in Geriatric Pharmacy for the first time, or recertified by either re-taking the examination or completing the Professional Development Program (PDP). Of these 53, 15 recertified either by examination or the alternative pathway of a combination of live and on-line continuing education. Expanding the ranks of CGPs inherently helps CCGP to expose more organizations, employers, and other healthcare professionals to the value of the credential.

As the leading organization responsible for credentialing all pharmacists involved in geriatric care, Chair Jane Huff stated: "CCGP is very pleased to congratulate this specialized group of individuals who are clearly committed to appropriate care of seniors. As the elderly population continues to grow and as new medications for conditions of aging are developed, geriatric pharmacy is a specialty practice area that will become increasingly important."

Want to confer easily with your fellow CGPs? Then sign up for the CCGP list server. As an added benefit to CCGP certification, you can post messages that share your queries and thoughts on issues and concerns. This will help provide timely information and encourage a broader dialogue among you and your colleagues.

These three recent posts on the CGP list server sparked exchanges among multiple CGPs:

- "I am calculating a corrected phenytoin level on a patient with ESRD who receives dialysis 3x week. Does the dialysis affect this calculation in anyway?
- "Can anyone please fill me in on what the standard of practice is in their SNF units regarding the handling/administration of ganciclovir, imuran, and 5-FU by "non-chemo" certified nurses, or even if these drugs are allowed to be administered at all in your SNF units. We are currently reevaluating our policy/procedures regarding handling/administration of these medications. Any help would be appreciated.
- Do any of your facilities currently use POC [point-of-care] testing for PT/INR? Do you have any pros/cons about this system?

- How will the patient population for this certification be defined and will the majority of that population be older persons?
- If so, how will the principles and practice of geriatric care be included in the certification process?
- How will this new credential complement the Certified Geriatric Pharmacist (CGP) credential?
- How will this new certification be communicated to the population that it intends to serve?
- How does this certification advance the profession in a way that consumers, caregivers, and purchasers of health care will understand its value?

The first open hearing to receive comments from the profession was held at the ASHP Midyear Clinical Meeting in Orlando in December 2008. CCGP representatives attended that hearing. Two more open hearings are scheduled in April in conjunction with the APhA meeting in San Antonio (April 5) and the ACCP Spring Meeting in Orlando (April 26). CCGP will represent your interests at these hearings. We invite you to join us for these hearings and provide your comments.

After its own review of the petition and all comments received, BPS will determine whether to recognize Ambulatory Care Pharmacy Practice as a new specialty. This decision is expected in mid-2009. If it is approved, work will then begin on developing and implementing standards, eligibility criteria, and a psychometrically-sound examination process. A first exam in the Ambulatory Care specialty would not be available before 2010.

CCGP will continue to monitor the progress of the petition and keep you posted.

### **CGP PUBLISHED IN LITERATURE**

# HIGHLIGHTS FROM RECENT BOARD MEETINGS

The CCGP Board of Commissioners met via conference call on November 13, 2008, and January 15, 2009, to tend to the governance, planning, and oversight needs of the Commission. Highlights were:

- Approved the 2009 budget, including an additional \$10,000 for marketing and development
- Elected Ken Tuell, CGP, to fill a vacant position on the Board of Commissioners representing a payor representative. Tuell, who works for Humana, will fill the remainder of the 2006-2009 term previously held by Mike Anderson, RPh, United Health Care.
- Elected Diane Crutchfield, CGP, to a Pharmacist Member position on the Board of Commissioners. Crutchfield will serve a three-year term, November 2008 November 2011.
- Elected CGPs Micah Sobota, Keith Swanson, and Sharon Vire to serve three-year terms on the Examination Development Committee, January 1, 2009 December 31, 2011.
- Elected Commissioner Eldon Armstrong to serve as Secretary/Treasurer of CCGP; and advanced Tom Lackner to Vice Chair, Wayne Atkinson to Immediate Past President, and Jane Huff to Chair, all effective November 19, 2008.
- Approved a pilot program at the University of Maryland School of Pharmacy to prepare pharmacy students to take the CGP exam after one year of experience rather than two years.
- Changed CCGP's fiscal year from the calendar year to October 1 September 30
- Established a subcommittee to explore CCGP's response to the BPS petition submitted by the American College of Clinical Pharmacy (ACCP), American Pharmacists Association (APhA), and American Society of Health-System Pharmacists (ASHP) for an Ambulatory Care Specialist Pharmacist: Diane Crutchfield, Jane Huff, Diane Tobias, and Ken Tuell.

# DATES TO REMEMBER AND OPTIONS TO RECERTIFY

#### 2009 Registration Deadlines to take the CGP Exam

- Register by April 30 to take the exam by May 31, 2009.
- Register by July 31 to take the exam by August 30, 2009.
- Register by October 31, 2009, to take the exam by November 30, 2009.

Computer-based exams will be administered exclusively in 2009. Due to so few candidates for the paper-based exam coupled with rising costs for its administration, the paper-based exam is no longer offered.

#### **Two Options to Recertify**

CCGP requires all Certified Geriatric Pharmacists (CGPs) to recertify every five years. Recertification assures the public and the profession that CCGP-certified pharmacists undergo periodic evaluation to verity that their knowledge and skills are maintained at a level comparable to newly Certified Geriatric Pharmacists.

To recertify, an individual must be licensed to practice pharmacy and successfully complete one of two methods:

- 1. Achieve a passing score on the multiple-choice, 150-question CCGP Certification Examination; or
- 2. Earn 75 continuing education hours over five years through the Professional Development Program (PDP) for CGP Recertification. CCGP has designated the American Society of Consultant Pharmacists (ASCP) as the exclusive provider of the PDP for CGP Recertification. This program's content is directly related to the content map from which the exam questions are developed. In addition to the online study at GeriatricPharmacyReview.com, you are required to complete two live workshops: "Clinical Update for the Geriatric Pharmacist" and "Geriatric Assessment for the Senior Care Pharmacist."
